I also agree to hold North Haven Camera Club and its officers, members, or assigns harmless in the event I suffer equipment theft, damage or loss; memory card theft, damage or loss; data loss; and/or the loss of any other personal property or physical injury while attending any Event. I agree that NHCC and its officers, members, or assigns are not liable for acts by humans or of God that may occur during any Event, including, but not limited to: severe weather, earthquakes, volcanic activity, war, terrorism, riot or other civil unrest.

**ASSUMPTION OF RISK:** As a participant in any Event, I acknowledge that I am expected to be in normal health and am willing to be responsible for my own actions.
